

# MEMORANDUM OF UNDERSTANDING

between

**Dhirendra Mahila P.G. College, Varanasi**

(Affiliated to State University M.G.K.V.P, Varanasi)

and

**DAV PG College, Varanasi.**

(Admitted to the privileges of Banaras Hindu University)



## Preamble

**Dhirendra Mahila P.G. College, Varanasi** hereinafter called the '**First Party**' and the **DAV PG College, Varanasi** (Admitted to the privileges of Banaras Hindu University) hereinafter called the '**Second Party**' and collectively called the '**Partners**', found it mutually beneficial to have a formal understanding between the Partners in taking up collaborative programs based on Common interest in Academics, Education, Research and administrative program implementation in the field of Commerce & Humanities. Both the partners have thus, arrived at an understanding as indicated below:

### 1. The Partners.

The Partners of this Memorandum of Understanding are the **Dhirendra Mahila PG College** represented by **Dr. Nalini Mishra, Principal** or its successors or lawful representatives on one side and the **DAV PG College, Varanasi** represented by **Prof. Mishri Lal, Principal** or its successors or lawful representatives of the college on the other side.

### 2. Objectives

The goal is to foster collaboration, provide opportunities for better experience, and to facilitate the advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions. **Partners** are agreed :

- ❖ to exchange information on teaching, learning material and other literature relevant to their educational programmes
- ❖ to jointly organize short-term continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein
- ❖ to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein
- ❖ The Partners will evolve a mechanism for exchange of experiences and expertise for mutual benefit of both the organizations.

### 3. Joint Sponsored Development and Consulting

**Partners** have agreed to help, identify and invite faculty members from the other institutions or organizations to participate in programs like career counseling, and guidance program for the students. The terms and conditions for each participation will be worked out by mutual agreement between the **Partners**.

#### 4. Student Exchange

**Partners** have agreed for Exchange of Student to improve the quality, value or attractiveness of knowledge keeping in view the following principles:

- **Home Institution** refers for the institution, where a student is a full-time student or admitted for the course of study and from where he/she expected to get his/her degree.
- **Host Institution** refers for the institution, that receives student for **short term** to undertake a pre-determined program of study or research.

Exchange of students will be based on the mutual agreement between the **Partners**. Home institution selects the student/s for exchange and Host institution agrees to accept the student/s vice-versa.

The students accepted by the Host Institution, will be treated as full-time student of his/her home institution. The student in reference can never claim as the regular student of the Host Institution.

#### 5. Exchange of Scientific and Technical Material

**Partners** will exchange information based on educational programs and teaching/learning material and other literature relevant to their educational programs.

Furthermore, **Partners** agree to explore ways to share technical/learning material, and other relevant literature, while respecting each other's intellectual property and other rights, not be used for any commercial purpose without obtaining written permission from **Partners** on suitable terms.

#### 6. Joint Conferences, Workshops and Short-term Courses

**Partners** agree to help, identify and invite faculty members from each other Institution to participate in Conferences, Workshops and Short-term Courses. The terms and conditions for such participation will be worked out by mutual agreeance between the Partners.

#### 7. Intellectual Property

**Partners** agrees to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a Case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions. The research outputs along with a short summary of conclusions would be made available to each other Institutions in the form of hard copy or on electronic media free of cost before they are published. Partners will have the right to reprint them in its in-house journal even if they are published elsewhere.

#### 8. Tenure and Termination

This MoU will come into effect on the date of signed by representatives of the two institutions. It will remain valid for five years, and may be continued thereafter by suitable review and agreeance of the Partners. Either first party or the Second Party have the right to terminate the MoU by giving written notice six months in advance. Once terminated, neither the First Party nor the Second Party will be responsible for any losses, financial or otherwise, which the other institution may suffer. However, it is desirable that the Partners will ensure that all activities in progress are allowed to complete successfully.



## 8. MODIFICATION

The MOU may be amended by mutual consent through an exchange of correspondences between the two Partners.

## 9. SIGNATURES

Signed, on the 27<sup>th</sup> day of January (English month) of 2025 (year) in two originals for each of the partners. **Dhirendra Mahila P.G. College, Varanasi, Uttar Pradesh** and **DAV P.G. College, Varanasi, Uttar Pradesh** welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
