



## MEMORANDUM OF UNDERSTANDING (MoU) BETWEEN



**UDAI PRATAP COLLEGE, VARANASI**

AND

**DHIRENDRA MAHILA P.G. COLLEGE, VARANASI**

THIS MEMORANDUM OF UNDERSTANDING (MoU) is executed at Varanasi on 1<sup>st</sup> day of May 2024 by and between **UDAI PRATAP COLLEGE, VARANASI**, India, an Autonomous Institution affiliated to MGKVP, Varanasi; recognized by UGC under Section 12 B & 2f of the UGC Act, 1956, having its registered office at Varanasi-221002, India and represented by its Principal **Dr. Dharmendra Kumar Singh** herein after referred to as 'UPC' (which expression shall, where the context so admits, mean and include its successors, lawful representatives and permitted assigns) of the First Party;

and

**DHIRENDRA MAHILA P.G. COLLEGE, VARANASI** an Institution in Varanasi, having its registered office at Karmajeetpur, Sunderpur, Varanasi-221005 India and represented by its Principal, **Dr. Nalini Mishra** hereinafter referred to as 'DMC' (which expression shall, where the context so admits, mean and include its successors, lawful representatives and permitted assigns) of the Second Party (hereinafter collectively referred to as "the Parties" and individually as "the Party"). WITNESSETH AS FOLLOWS: -

**UPC** and **DMC** have many areas of common interest in academic, education and research such as Sciences, Social Science, and Humanities considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research, and administrative.

NOW THEREFORE, **UPC** and **DMC** have decided to enter into this Memorandum of Understanding (here-in-after referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

### 1. Objectives

The goal is to foster collaboration, provide opportunity for better experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions. **UPC** and **DMC** are agreed:

to exchange information on teaching, learning material and other literature relevant to their educational programmes

to jointly organize short-term continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein

to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein

## **2. Joint Sponsored Development and Consulting**

UPC and DMC agree to help identify and invite faculty members from the other institution to participate in career counseling and guidance programmes. The terms and conditions for such participation will be worked out by mutual agreement between UPC and DMC.

UPC and DMC agree to encourage collaboration between faculty and staff from the two institutions. Specifically, institutions will encourage members of their faculties to undertake short visits to, or take up fixed-term visiting assignments at, each other's institution as per the existing norms.

## **3. Student Exchange**

UPC and DMC agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

Exchange students will be selected by mutual agreement between the home institution and the host institution.

An exchange student will continue to be treated as full-time student at his/her home institution.

## **4. Exchange of Scientific and Technical Material**

UPC and DMC will exchange information on educational programs and teaching/learning material and other literature relevant to their educational programs. Further, UPC and DMC agree to explore ways to share teaching/learning material, and other relevant literature, while respecting each other's intellectual property and other rights.

## **5. Joint Conferences, workshops and short-term courses**

UPC and DMC agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short-term courses. The terms and conditions for such participation will be worked out by mutual agreement between UPC and DMC.

## **6. Intellectual Property**

UPC and DMC agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under




this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.


#### 7. Tenure and Termination

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for five years, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither **UPC** nor **DMC** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, both the institutions will ensure that all activities in progress are allowed to complete successfully.
